### 강의내용:

본 세미나는 최근 자연과학과 사회과학에서 주목받고 있는 ‘네트워크 이론’의 시각을 원용하여 21세기 세계정치의 변환을 이론적·경험적으로 탐구한다. 세미나의 서두에서는 네트워크의 시각을 원용하여 세계정치의 변환을 이해하려는 기준 연구를 검토하고, 네트워크 세계정치를 이해하는 데 필요한 기초 개념과 이론 및 방법론 등에 대해서 살펴본다. 이후 세미나의 대부분 시간은 21세기 세계정치의 변환을 보여주는 이론적 논제들을 검토하는 데 활용한다. 특히 국제정치이론의 주요 개념인 ‘권력’, ‘국가’, ‘구조’ 등의 변환을 네트워크 이론의 시각에서 살펴본다. 이러한 이론적 논제들의 탐구를 위해서 기술·정보·지식, 커뮤니케이션·문화, 환경·인권, 경제(무역·금융·생산), 군사·안보, 글로벌 거버넌스·외교 분야 등에서 활발히 진행되고 있는 네트워크 세계정치의 경험적 사례들을 검토한다. 이러한 과정에서 본 세미나가 초점을 맞추는 것은 기존의 노드 중심의 국제정치(國際政治, inter-national politics)를 넘어서 네트워크 행위자들 간에 형성되는 망제정치(網際政治, inter-network politics)의 부상을 이론적·경험적으로 파악하는 작업이다.
