### 강의내용:

본 세미나는 최근 발생하고 있는 세계정치의 변화를 다루는 기존 국제정치이론의 빈곤에 대한 문제제기에서 시작한다. 현실주의, 자유주의, 구성주의 등으로 대변되는 기존의 주류 진영은 주로 노드(node) 기반의 이론화를 추구함으로 인해서 관계적 맥락에서 벌어지고 있는 네트워크 세계정치의 부상을 제대로 파악하지 못하고 있다. 이러한 문제의식을 바탕으로 본 세미나는 최근 국내외 학계에서 주목받고 있는 '네트워크 세계정치이론(Network Theory of World Politics, NTWP)'의 시각을 활용하여 21세기 세계정치의 변화를 이론적·경험적으로 탐구할 것이다. 본 세미나의 진행은 주로 기존의 국제정치이론에서 다루어진 '질서(order)'와 '변화(change)'에 대한 이론적 개념에 초점을 맞출 것이다. 이들 개념을 이해하고 그 적실성을 검토함에 있어서 주로 기존 국제정치이론과 네트워크 세계정치이론의 '모의토론'의 방식을 취할 것이다. 이론적 탐색을 벌일 세미나 토론에 비해서 학생들의 기말논문 주제는 기술·정보·지식, 커뮤니케이션·문화, 환경·인권, 경제(무역·금융·생산), 군사·안보, 글로벌 거버넌스·외교 분야 등의 다양한 경험적 사례를 포괄하는 방향으로 지도될 것이다.
